Ohio Schools and Sex Education: A Summary of School District Responses to ODE Sex Ed Audit, 2022

What is the status of sex education in Ohio schools? How well are individual school districts adhering to the state law in the Ohio Revised Code that requires an emphasis on abstinence until marriage and avoidance of teen sexual activity? (See Appendix 1)

The Ohio Department of Education recently conducted an <u>audit</u> of all school districts on this question. They reminded school districts about the requirements for abstinence (also called SRA, sexual risk avoidance education) and you can read the exact instructions as communicated to school districts in Appendix 2 as well as the findings. Schools were not required to give details, according to the ODE instructions. This is the first of several major flaws in the conduct of this audit.

<u>Protect Ohio Children</u> along with <u>Mission America</u> examined the results reported in October 2022 by the Ohio Department of Education.

About this Report

Our analysis provides both good news and bad news, and we have tried to summarize both below. Many school districts did not respond at all to the ODE audit, or gave minimal information, which should be a red flag. Local parents need to get involved and encourage those school districts to report, in a spirit of transparency, what they are teaching to children.

<u>Sexual risk avoidance (abstinence until marriage education)</u> has been a requirement in Ohio law since 1999. Schools are required to teach programs that emphasize abstinence and do not encourage teen sexual debut, but disclose the known risks to teens of sexual activity.

In the summer of 2021, the existing abstinence law was enhanced by requiring schools to disclose what they are teaching each year to ODE and, if instruction does <u>not</u> follow the standard of abstinence, to fully inform parents and obtain written permission. <u>If a school is following a clear abstinence standard in its teaching, then no special "opt in" for that instruction is needed.</u>

As allowed in the Ohio Revised Code, parents can still "opt out" of approved abstinence instruction if they like, although few do so, but no school should be requiring an "opt in" if the teaching follows the abstinence standard, compliant with Ohio law. The "opt in" is only required if non-abstinence instruction is planned.

The goal is for school districts to achieve compliance with Ohio law. Many districts claim they are compliant. Our analysis finds that, unless the Ohio Department of Education has other information not made available in the audit report, many schools fail to be compliant with the requirement to emphasize abstinence until marriage and the risks of teen sexual activity. We

contacted ODE personnel asking if other information was received from school districts and not included in the published report. There has to date been no answer from ODE to that question.

The results below reflect our analysis regarding school district compliance. Our results for many districts are at variance with the ODE audit report.

In spite of the law and the responsibility to set a high standard for children, some Ohio districts have embraced lessons that fall into the category of "comprehensive sex education" (CSE). These lessons typically mention abstinence in passing but concentrate on giving students "skills" for contraception/condom use, present an uncritical view of abortion as an alternative, and minimize the risk of sexually transmitted infections. Many CSE curricula describe sex acts in detail (vaginal, anal and oral sex) and suggest that students can engage in these with little negative results if "protected." CSE lessons usually advocate LGBTQ conduct, disregarding the known risks of these identities and behaviors. Many CSE programs are now presented to students as early as 7th grade.

CSE programs violate Ohio law because adolescents are left with a "go ahead, it's not that risky, you can manage it" impression about sexual activity. Many schools falsely claim that CSE programs emphasize abstinence. THIS IS INACCURATE. If a student's impression, once the lessons are complete, is that sexual behavior is possible and even normal for teens with minimal risk, this is not abstinence. Simply mentioning abstinence in passing as one option does not satisfy the law's specific language and requirement. The good news in Ohio is that we have many school districts with a history of adhering to Ohio law, fulfilling their responsibilities to students, and have focused on delivering a clear abstinence message.

The bad news is that other districts, especially those in Ohio's larger cities, are denying their students the lifelong benefits of a positive, clear abstinence message, of hearing the whole truth about the risks of teen sexual activity, and instead have adopted CSE curriculum choices. Some of these curricula are products developed by Planned Parenthood and their allies. According to our calculations, based on the ODE Audit report, 20% of Ohio's students are being shortchanged by not learning an uncompromised abstinence standard because they attend school in non-compliant districts. Misleading, irresponsible instruction on sexuality puts these students at higher risk.

One important point needs to be emphasized. According to the revision of the Ohio Revised Code in 2021, <u>parents are to be notified</u> if a school plans to teach any sex education material other than what is specified in the law (in other words, emphasizing abstinence and the avoidance of teen sexual behavior). Parents are to be given information about and a chance to opt in to the non-compliant program. Again, if a program is compliant with Ohio law and truly emphasizes abstinence, parents do not have to opt in. They are permitted to opt out, but no "opt in" is required.

Are those districts with CSE programs following Ohio law and notifying parents?

This section from the Ohio Revised Code was not included in school audit reporting instructions sent to districts by ODE, but should have been--

"2) If a school district or school chooses to offer additional instruction in venereal disease or sexual education not specified in division (C)(1) of this section [the abstinence standard], the district or school shall notify all parents or guardians of that instruction, including the name of any instructor, vendor name, if applicable, and the name of the curriculum being used. No district or school shall offer that instruction to a student unless that student's parent or guardian has submitted written permission for that student to receive that instruction." (Emphasis added)

Results

Below is a summary of the good, the bad and the unknown (since many districts did not respond to the audit.)

<u>To find your district</u>, look at each category and search alphabetically. Some of the information provided was not clearcut, so we have done our best to place school districts where their responses dictate. <u>Some districts are listed in several categories</u> if there were questions about a portion of their instruction, so be sure to check all the categories for your district.

3. SCHOOLS NON-COMPLIANT with Ohio Law, who seem to be in violation of Ohio standards by teaching CSE material or failing to address the audit in detail.

Sadly, when one accounts for the student population in these school districts, 300,000 students are being denied a clear abstinence message.

Allen East Local (Lima and Toledo area): 'Organization is the YWCA of Lima and Toledo. The middle school curriculum is called "<u>Draw the Line/Respect the Line (DTL)"</u>. The high school program is called "<u>Reducing the Risk</u> (RTR)"' These are both highly inappropriate CSE curricula.

Beachwood City—using HealthEducationtoday.com, which appears to be CSE

Benton Carroll Salem Local: Uses material from ETR Associates, a network partner of Planned Parenthood

Bexley City: teaches both <u>Get Real</u> (a <u>Planned Parenthood developed CSE curriculum</u>) and also Glencoe text and CDC material

Boardman Local: teaches <u>Health Smart</u> from ETR Associates, a Planned Parenthood network partner

Carrolton Exempted Village—This district uses online websites on consent and "healthy relationships" that seem to take teen sexuality as a given, rather than stressing abstinence until marriage.

Chagrin Falls Exempted Village—Teaches "Power to Decide," a condom & abortion-friendly curriculum.

Cincinnati City Schools claims to be compliant, but uses Goodheart-Wilcox material, copyright 2018, which they identify as "correlating with National Sexuality Education Standards." These standards are not abstinence-oriented—quite the opposite. The NSES were developed by abortion-supporting groups and advocates of teen sexuality, with no pro-life or genuine abstinence groups participating

Cleveland Heights – teaches Edgenuity, which appears to be a CSE curriculum

Cleveland Municipal Schools—Teaches <u>FLASH</u>, a pro-abortion, condom-friendly CSE curriculum developed in Seattle.

Cloverleaf Local –uses a CSE textbook

Columbus City Schools: "All sexual education followed the <u>National Sexual Education</u>
<u>Standards.</u> However, the district is in the planning process of purchasing 'Get Real' Teen
Reproductive Materials for this school year." <u>Get Real</u> is a very inappropriate CSE curriculum.
Not compliant

Crestview Local (Columbiana)—incomplete, not compliant

Danville Local—in progress, incomplete, not compliant

Dayton City—Not compliant—"Due to the late timing of the legislation, we were unable to write and implement a new curriculum."

Eastern Local School District (Pike)—Inadequate response, not compliant

Edgewood City—In progress, not yet compliant

Federal Hocking Local—Incomplete. Uses Athens City Health Department, raising questions about abstinence focus

Firelands Local Schools invites "Family Planning of Lorain County" to give presentations to students. A family planning provider is not an abstinence focus.

Green Local (Scioto)—Non-compliant. Used materials from Sex Education Collaborative website, which is a CSE site, not abstinence SRA focused.

Greenfield Exempted Village—Teaches from Prentice Hall Health

Groveport Madison Local—Reports using SIECUS, a radical group advocating CSE and child sexuality. Not compliant.

Harrison Hills City –online material from Nemours Foundation, apparently CSE

Jefferson Township Local—Not compliant. Reported this: "The district did not partner with an authorized provider of this content. Nor did the district purchase a program to use internally to teach these concepts."

Jonathan Alder Local—Not compliant, reported a timing issue during change from middle school to high school sex ed.

Lakewood City -- CSE

Leipsic Local – Incomplete because of staff change.

Lexington Local: "We use Edgenuity's Contemporary Health content as part of a teacher-delivered unit." https://www.edgenuity.com/Syllabi/mi/electives/ContemporaryHealth-Syllabus.pdf. Looking at this Edgenuity curriculum, it does not give enough details, but seems likely to be a comprehensive sexuality curriculum (CSE) which would not qualify as abstinence-focused.

Lima City—Not compliant. Uses "<u>Draw the Line/Respect the Line</u>," a very inappropriate CSE curriculum

Manchester Local (Adams) -- Not compliant because of new superintendent and new staff

Marion City -- Partner with Marion Adolescence Pregnancy Program - https://marion-mapp.com/. Not compliant. This is a group advocating teen condom use.

Middletown Local -- The Women Helping Women organization presented on the topic of "positive relationships, consent and sexual assault." https://www.womenhelpingwomen.org/
This is a social justice group that pushes a narrative of "white supremacy" and refers to GLSEN as a resource. Not balanced and not abstinence focused.

Monroeville Local—Uses ETR Associates material. Not compliant, not abstinence focused.

Napoleon Area City – Incomplete this year but plans compliance: "Project Respect has been used before Covid. The district is planning on using the organization for the 22-23 school year. This is an abstinence-based program. Our school resource officer discusses the legal ramifications of classes. We offer a school-wide program with our local police department and prosecutor to discuss the criminal aspects of having sexual contact with someone under the age of sixteen. HS text: Health A Guide to Wellness, 2001JH text: Glencoe Teen Health: Course 2, 2009"

North Baltimore Local – Questionable. Uses Wood County Health Department

Northeastern Local (Clark) – "Program <u>Get Real Comprehensive Sex Education That Works</u> through Planned Parenthood." CSE program, not compliant

Northridge Local (Licking)—Not compliant. "We had a new teacher and she said she did not read the standards."

Norwalk City—Insufficient response, not compliant. "Health education class at the high school."

Oakwood City –Not compliant. Uses <u>Health Smart</u>, produced by ETR Associates, a CSE curriculum provider affiliated with Planned Parenthood

Oberlin City Schools – Uses Glencoe text. May be compliant but it's unclear. The Glencoe/McGraw Hill online textbook Glencoe Health. Here is the table of contents: https://s3.amazonaws.com/ecommerce-prod.mheducation.com/unitas/school/explore/sites/glencoe-health/glencoe-health-2022-toc.pdf

Oregon City-- Not compliant, Uses <u>Health Smart</u> curriculum, produced by ETR Associates, a CSE curriculum provider affiliated with Planned Parenthood

Painesville City Local—Not compliant. Partners with teen contraceptive provider, Family Planning Association of Northeast Ohio https://ashtabulacountyhealth.com/?page_id=1221

Perry Local (Allen) – Not compliant. "The program was called "Reducing the Risk" and was presented by a member of the YWCA of Northwest Ohio." This is a CSE curriculum.

Perry Local (Lake)—Not compliant, partners with a family planning/ teen contraceptive provider). "Lake County Public Health/Family Planning Department provides the curriculum."

Perry Exempted Village – Not compliant, uses <u>Health Smart</u> curriculum, produced by ETR Associates, a CSE curriculum provider affiliated with Planned Parenthood

Poland Local—May be compliant, uses Glencoe text

Revere Local—Insufficient response, "reviewing resources"

Ridgewood Local—not compliant, "not part of our curriculum"

Rolling Hills Local -- Insufficient response, not compliant

Ross Local -- Insufficient response, not compliant

Sandy Valley Local – Not compliant. "Edgenuity -https://www.edgenuity.com/Growth,
Development, and Sexual HealthTopics: Puberty, gender identity and sexual orientation
•Abstinence, safe sex and making informed decisions •Conception, pregnancy and birth
•Sexually transmitted infections, HIV and AIDS." [Gender identity, sexual orientation and 'safe sex' are not responsible, abstinence-until-marriage lessons.]

Shaker Heights City—Not compliant. Used speakers from Planned Parenthood. "Information can be located at: https://www.plannedparenthood.org/planned-parenthood-greater-ohio/education-training/center-sex-education"

Southern Local (Columbiana) — Insufficient information. "The district chooses not to include the venereal and sexual education courses in our online health programming."

Springfield City – Not compliant with standards, but may have followed appropriate opt out. Partners with Planned Parenthood "Planned Parenthood and Family First were local partners and delivered in class programs. Family First provided their institutions opt-out letter."

Springfield Local (Lucas) – Not compliant, uses <u>Health Smart</u>, produced by ETR Associates, a CSE curriculum provider affiliated with Planned Parenthood

Springfield Local (Mahoning) – Insufficient information. "No Instruction on health issues that included all diseases, not just a focus on venereal disease, was delivered."

St. Bernard Elmwood Place City—Not compliant. Confusing, error-ridden submission provided, including false claims about state law:

"Instruction will be usually provided by our High School Health teachers. Schools and teachers may partner with organizations like Planned Parenthood to deliver instruction. Please contact your child's teacher for more information about instructional delivery. Ohio state law requires that comprehensive sexual health education and STI prevention education be provided to students at least once in high school. Instruction must encourage students to communicate with parents, guardians or other trusted adults about human sexuality. Instruction must be medically accurate, age-appropriate and inclusive of all students. It must include the following:? Information about HIV and other sexually transmitted infections (STIs), including transmission, FDA approved methods to prevent HIV and STIs, and treatment? Information that abstinence is the only certain way to prevent unintended pregnancy and HIV and other STIs and information about value of delaying sexual activity? Discussion about social views of STIs? Information about accessing resources for sexual and reproductive health care? Information about pregnancy, including FDA approved prevention methods, pregnancy outcomes, prenatal care, and the newborn safe surrender law? Information about healthy relationships and avoiding unhealthy behaviors and situations (including human trafficking)."

Strasburg-Franklin Local. May be compliant but unclear. "Strasburg-Franklin Local School District uses state standards for health as well as the T-4-C curriculum of "Health Choices for Youth Program" through the Tuscarawas County Council for Church and Community. The district utilized the programming in 7th (and 9th) grade health."

Three Rivers Local – uses Edgenuity

Toledo City—Not compliant. Uses a CSE curriculum. "We partner with the YWCA to provide the Draw the Line/Respect the Line (grades 6-8) and Reducing the Risk curriculum (secondary Health). Both programs are ETR products. The district also adopted Glencoe Health and Glencoe Human Sexuality, a comprehensive health education curriculum, which will be implemented at the start of the 2022-23 school year."

Tri-County North Local –Not compliant. Uses <u>Health Smart</u>, produced by ETR Associates, a CSE curriculum provider affiliated with Planned Parenthood

Warren City—Insufficient information. "District teachers employed to teach health education." Not compliant

Warren Local – Insufficient information. Not compliant.

Warrensville Heights City—Not compliant. Teaches "Teen Works: No Kidding Ohio," which has many positive qualities but uses peer (teen) educators, not a reliable abstinence focus. Also uses "216Teens.org" and Beech Brook, which feature CSE.

Waynesfield- Goshen Local—Not compliant. Teaches "Reducing the Risk," a highly inappropriate CSE curriculum

West Carrollton City-- Not compliant. Cites use of "Planned Parenthood."

Western Local – Compliance unclear. Uses Glencoe text.

Worthington City Schools: "Comprehensive Health - Goodheart-Wilcox 2018." This text aligns with the <u>National Sexuality Education Standards</u>, which are not abstinence-based.

Wyoming City – May be compliant, but unclear. Uses Prentice Hall text and online courses from Brigham Young.

Yellow Springs Exempted Village—Not compliant because of conflicting messages. Uses "Making Proud Choices, " a highly inappropriate CSE curriculum but also a pregnancy resource center for abstinence.

HEALTH Textbooks

Many use textbooks and adherence to abstinence requirements is uncertain. For instance:

Cloverleaf Local—Uses Sanderson Zeleman text which seems to be CSE, not abstinence

Clyde-Greenspring – Uses Lifetime Health which seems to be CSE

Edison Local—Uses Pearson text which seems to be CSE not abstinence

Fairbanks Local – Uses Prentice Hall Health which seems to be CSE not abstinence

Cincinnati City Schools claims to be compliant, but uses Goodheart-Wilcox material, copyright 2018, which they identify as "correlating with National Sexuality Education Standards." These standards are not abstinence-oriented—quite the opposite. The NSES were developed by abortion-supporting groups and advocates of teen sexuality, with no pro-life or authentic abstinence groups participating.

Other schools using the Goodheart curriculum are **Bethel-Tate**, **Columbus City**, **Chillicothe City**, **Fairborn City**, **Garfield Heights City**, **Lordstown Local**, **Loudonville- Perrysville Exempted**, **Miami East Local**, **Norwood City**, **North College Hill** and **Worthington City**.

The NSES advocates "sexual orientation" and "gender identity and expression" as being worthwhile options, and no other views are provided. It is not responsible to advocate these high risk behaviors.

Among the student goals in the <u>National Sexuality Education Standards</u> is to "Compare and contrast the advantages and disadvantages of abstinence and other contraceptive methods, including condoms." Another goal is to "Access medically-accurate information about contraceptive methods, including abstinence and condoms." And another is to "Apply a decision-making model to choices about contraception, including abstinence and condoms." Programs that discuss the option to use condoms or "choices about contraception" are advocating/accommodating teen sex in some circumstances and do not qualify as abstinence-focused.

7. Some Schools refer to the Centers for Disease Control (CDC)

CDC is generally not abstinence-focused, but recommends CSE (comprehensive sex education) curricula. These schools cited CDC as their source for teaching without enough added detail to validate compliance:

8. Schools Providing Little Information

Some schools gave pathetically little information. For instance, **Austintown Local** reports using "Life Skills Training," but the link cited relates to drug use education, not sex ed.

Hudson City reported only this: "Hudson approved and adopted the Health textbook (2020)." What does this mean? Such minimal response is disrespectful to the Hudson community and the seriousness of this topic.

Others with similar minimal response—James A. Garfield Local and Rootstown Local both reported, "Town Hall II." What is this program?

Bay Village reports that their districts uses a "board-approved curriculum." That's all the information we get.

Lockland Local and **Coshocton Local** both tell us they use https://www.apexlearning.com, yet this is online learning with many different subjects. Where are the specifics about sexuality education?

Same with **Joseph Badger Local**, which only reported, "Fuel Education." This is a supplier of many subjects for online learning and this response gives insufficient detail. And **Johnstown-Monroe Local** reports the use of www.getfueled.com, which is another online provider with many subjects. Much more detail needed.

Franklin Local reported only "FLSD." Is this their own internally produced curriculum?

Maysville Local only reported, "All well." Some verification/details would surely be appreciated by Maysville families. **National Trail Local** reported, "ENLC"—what is this?

9. SCHOOLS in Partnership with Health Departments

A number of districts partner with <u>local and state health departments</u>, yet this gives us no information about compliance with abstinence standards. Many health departments are very committed to teen contraception/abortion, not a strong abstinence recommendation, so much more detail is needed. Among these schools are:

Respect the Line. It claims to be abstinence focused but is definitely not.

State law requires the Ohio Department of Education to conduct an annual audit of each city, local and exempted village school district regarding its compliance with the requirements for venereal disease and sexual education instruction. This document consists of the audit findings from Ohio school districts that self-reported information regarding venereal disease and sexual education instruction and course materials used during the 2021-2022 school year. This audit will be conducted annually and its findings will be published on the Department's website.

Compliance was based on the responses to Questions 1 and 2. (*see below*) Districts were required to self-report relevant information regarding venereal disease and sexual education instruction to the Department. The window to have completed the audit was July 1 – September 1, 2022. The Department sent email notifications and reminders directly to school superintendents/superintendent designee regarding the audit reporting requirements and deadlines. The Department also notified districts through the Department newsletter, EdConnection, Urban Leaders Chief Academic Officers monthly calls, communication with ESCs, presentation at Connect and Collaborate Conference, as well as during regional superintendent meetings hosted by Buckeye Association of School Administrators (BASA). Technical support was provided to districts via phone, email and virtual meetups to support districts in the process during the audit window. Districts who did not report during the audit window were notified by email and the audit window reopened September 7 – September 16 to allow for those districts to submit their information. The final audit shows that 83% of districts completed the information for the audit with an additional 4% who were in progress. Districts that have an "Overall Non-Compliant" and "Overall Not Submitted" statuses will receive an email follow-up from the Department stating reason(s) for non-compliance.

District Reporting Status:

- "Completed" districts who answered yes to both question 1 and 2 and submitted their information in the system.
- "Not started" districts who did not enter the system to submit their information
- "In Progress" districts who did not completely answer questions and did not submit their information; or districts who entered the system but did not answer any questions

Compliance:

 "Overall Compliant" – districts who answered "yes" to questions 1 and 2 and submitted their responses

- "Overall Non-Compliant" districts who answered "no" to questions 1 and/or 2; or who did not completely answer questions 1 and/or 2 and submitted their responses
- "Overall Not Submitted/Non-Compliant" districts who may have answered questions 1 and/or 2 but did not submit their responses

Compliance

Districts that reported information were determined "overall compliant" or "overall non-compliant" based on their responses to questions one and two.

The following section provides the individual responses provided by each district to the data reporting requirements.

Question 1:

Pursuant to Ohio Revised Code 3313.60, did your district offer venereal disease and sexual education instruction during school year 2021-2022? Further details or explanations were required for Question 1.

- If yes, please provide the name of any organization or program that provided venereal disease and sexual education instructional materials, including title, copyright and link to the organization or program.
- If no, please explain why students did not receive venereal disease and sexual education instruction.

Question 2:

Did your district offer course material and instruction in venereal disease and sexual education courses, pursuant to Ohio Revised Code 3313.6011, that do all the following? Explanations were optional and not required for Question 2.

- Stress that students should abstain from sexual activity until after marriage.
- Teach the potential physical, psychological, emotional, and social side effects of participating in sexual activity outside of marriage.
- Teach that conceiving a child out of wedlock is likely to have harmful consequences for the child, the child's parents, and society.
- Stress that sexually transmitted diseases are serious possible hazards of sexual activity.
- Advise students of the laws pertaining to the financial responsibility of parents to children born in and out of wedlock.
- Advise students of the circumstances under which it is criminal to have sexual contact with a person under the age of sixteen pursuant to section 2907.04 of the Revised Code.
- Emphasize adoption as an option for unintended pregnancies.
