# Regular and Annual Business Meeting of the City Council January 12, 2021

#### **CALL TO ORDER**

Wayne Olsen, Mayor called meeting to order at 6:00p.m. Recited the Pledge of Allegiance.

# ANNUAL BUSINESS MEETING

Election of Council President: Councilman Wall Volunteered to be president for one calendar year, by acclamation, councilman Wall be Council President.

Establishment of Council Meeting Date/Time: Councilman Wallin made a motion that there be no change to Council Meeting falling on the second Tuesday of the month at 6:00p.m. in the Mackay City Hall Chambers, Councilman Mangum seconded it. The motion passed unanimously.

Assignment Council Member Duties: Councilman Wall- will remain with the O.W. Business Park and Industrial Park.

Councilman Wallin- will remain with the City Sewer/Water.

Councilman Mangum- changed from Parks to Streets and Airport as there is more of a need in the Streets Department than Parks Department. Mayor Olsen will cover the Parks Department until another Councilmember is found.

Mowing Contract for 2021-Mowing services agreement between the City of Mackay and Cody Harding. Lawn Mowing Services for the parks, questions about contract were answered. Councilman Mangum made a motion to approve, Councilman Wall seconded it. The motion passed unanimously.

Part City Account Setup in Acro- Advance Auto in Arco is able to do work on vehicles when it is needed. Councilman Wall made a motion to set up an account with Part City in Arco, Councilman Wallin seconded it. Motion passed unanimously.

Purchase of Snow Plow for Little Dump Truck- found a used snow plow overall cost for a used plow comes to over \$7,000; however, we can get a brand-new snow plow installed for \$8,155. Councilman Wall made a motion to approve purchase of new snowplow, Councilman Wallin seconded it. The motion passed unanimously.

Councilman Mangum: Not a lot about Parks. Continue to pursue holiday light contest for next year.

Councilman Wallin: Problems with a few lift stations, but getting it under control. City shop looks great.

Councilman Wall: Quiet at the Business Park, need to take down sign for the Technology park, hoping to get playground equipment update.
