Updated Materials on COVID-19 Vaccination

Monday's (1/25/21) press conference highlighted the start of Phase 2, beginning with vaccines for people aged 75 and older. Public and private low income and affordable senior housing are still prioritized in Phase 2, along with people 65+ and those with two or more co-morbidities, anticipating roll out later in February. The guidance posted earlier regarding prioritizing clinics for affordable <u>senior housing</u> still stands. The graphic on Mass.gov was changed for the purposes of simplification, knowing that residents of age restricted public and private affordable housing would be included in that demographic. Staff and residents younger than 65 are also still included in the senior housing roll out. For more details on the rollout for the 75+ population, please see attached fact sheet.

Phase 2

(February-March 2021)

Listed in order of priority:

- Individuals age 75+
- Individuals age 65+, individuals with 2+ <u>comorbidities</u> (only those conditions listed as at increased risk for severe illness), and/or residents and staff of low income and affordable senior housing.

Additionally, the Commonwealth has substantially updated the materials at the <u>COVID-19</u> <u>Vaccinations for Senior Housing Settings | Mass.gov</u>. This now includes a <u>Frequently Asked Questions</u> on setting up an on-site clinic in senior affordable housing, talking points for staff to use with residents and other staff on the benefits and safety of the vaccines, and a variety of educational materials that can be shared with residents. We encourage all LHAs to review the updated website, which is also linked through the Commonwealth's Vaccine Distribution Timeline.

COVID-19 Vaccinations for Senior Housing Settings

Residents and staff of public and private low income and affordable senior housing are included in the Phase Two of vaccine deployment in the Commonwealth of Massachusetts, which we anticipate to begin in February.

Public and private low income and affordable senior housing is defined as any residential premises available for lease by older or disabled individuals which is financed or subsidized in whole or in part by state or federal housing programs established primarily to furnish housing rather than housing and personal services. Specifically, this includes the following types of age-restricted housing properties:

- Public housing properties designated primarily for older adults that are owned/operated by Local Housing Authorities. This includes those public housing properties owned by a Housing Authority but managed by a private company.
- Privately owned rental properties designated for older adults that are financed in whole or part through resources made available from DHCD, MassHousing, or the U.S. Department of Housing and Urban Development (HUD), and in which the majority of units are restricted to residents earning less than 80% of Area Median Income.

"Residents" include those household members currently on the lease for a rental unit in public and private low income and affordable senior housing.

"Staff" includes all persons, paid or unpaid, working or volunteering at each of the qualified housing locations, who have the potential for exposure to residents or to infectious materials, contaminated environmental surfaces, or contaminated air.

To learn more about the currently available COVID-19 vaccines, please visit the CDC websites on the Moderna and Pfizer vaccines. Both vaccines require two doses for an individual to be fully vaccinated. It is critical that the second dose be the same as the first dose. Individuals must receive their second dose within a specified time frame and from the same location that they received their first dose.

COVID -19 INFO

Covid-19 Alert: Cases, hospitalizations and deaths across the United States are rising. As cold weather moves in, people spend more time indoors. As the holidays approach, take steps to slow the spread of COVID-19.

Wear a mask, stay at least 6 feet apart, avoid crowds, and wash your hands often and avoid touching your nose mouth and eyes.

Masks should be used as part of a comprehensive strategy to suppress the transmission of COVID-19, and to help in possibly saving the life of the wearer or others. Make wearing a mask part of you daily routine when outside or in contact with others. In an effort to make them as effective as possible, please adhere to the following recommendations:

- Clean your hands before you put your mask on, as well as before and after you take it off, and after you touch it at any time.
- Make sure it covers your nose, mouth, and chin.
- Store the mask in a clean plastic bag after you take it off, and every day either wash it if it's a Fabric mask or dispose if a medical mask.
- Do not use masks with valves.
