ABOUT THIS REPORT

About Protect Ohio Children

The Protect Ohio Children Coalition is being facilitated by Ohio Value Voters under the guidance of the National Protect Child Health Coalition (PCHC) which is a network of concerned citizens, parents, professionals, leaders and organizations representing the fields of law, academia, mental and physical health, politics, religion, government and more who believe that all children should be protected from harmful materials, especially pornographic, obscene, or erotic materials.

Purpose and Goals

1. FIND EVIDENCE OF OBSCENITY

Find Ohio schools that are using Comprehensive Sexuality Education Curriculum (CSE) produced by Planned Parenthood and their allies.

2. BUILD THE COALITION

Build a coalition in Ohio to monitor materials that could be harmful to minors.

3. STRENGTHEN AND CHANGE OHIO LAW

Influence the Ohio legislature to strengthen and change Ohio law to protect children from CSE.

This Public Records Report

This report represents our collection of public information and research done since 2017. Public records requests were sent to government agencies and public schools pursuant to the Ohio Public Records Act, R.C. 149.43 and the Freedom of Information Act, 5 U.S.C. § 552, (and/or the Privacy Act, 5 U.S.C. § 552a,) Information was requested about sexuality education grants and specifically we requested information about pregnancy prevention and HIV prevention education with an objective to find harmful curriculum.

Ohio Revised Code Sec. 3313.6011 "education...shall emphasize that abstinence from sexual activity is the only protection that is one hundred percent effective...."
(1) Stress that students should abstain from sexual activity until after marriage;
(2) Teach the potential physical, psychological, emotional, and social side effects of participating in sexual activity outside of marriage;"

Ohio Revised Code Sec. 3313.6011

According to (effective 2001; 2008 HB7) Ohio Education Title 33^{iv} (as of July 2, 2018) 3313.6011^v

As used in this section, "sexual activity" means sexual conduct or sexual contact, or both.

Instruction in venereal disease education shall emphasize that abstinence from sexual activity is the only protection that is one hundred percent effective against unwanted pregnancy, sexually transmitted disease, and the sexual transmission of a virus that causes acquired immunodeficiency syndrome.

The state board of education shall require course material and instruction in venereal disease education courses taught to do all of the following:

Stress that students should abstain from sexual activity until after marriage;

 Teach the potential physical, psychological, emotional, and social side effects of participating in sexual activity outside of marriage;

 Teach that conceiving children out of wedlock is likely to have harmful consequences for the child, the child's parents, and society;

Stress that sexually transmitted diseases are serious possible hazards of sexual activity;

 Advise students of the laws pertaining to financial responsibility of parents to children born in and out of wedlock;

 Advise students of the circumstances under which it is criminal to have sexual contact with a person under the age of sixteen

Emphasize adoption as an option for unintended pregnancies.

Any model education program for health education the state board of education adopts shall conform to the requirements of this section.

According to the Department of Education - Upon written request of the student's parent or guardian, a student shall be excused from taking instruction in venereal disease education. vi

From Our Program Manager

Thank you for reviewing this report that represents two years of research and investigation by our team. This report proves that Planned Parenthood and their allies, working closely with Ohio universities and through county and federal grants and private donations, have infiltrated Ohio schools by presenting harmful materials to minors. Page 5 references the "15 Harmful Elements of Comprehensive Sexuality Education." These are the elements of sexuality education that should be immediately removed from Ohio schools and should be used by citizens and the Ohio General Assembly to distinguish between acceptable and unacceptable curriculum. Comprehensive Sexuality Education is out of compliance with Ohio Revised Code 3313.6011.

COMPREHENSIVE SEX EDUCATION: THE HARMFUL EFFECTS ON CHILDREN



1. SEXUALIZES CHILDREN

Normalizes child sex or desensitizes children to sexual things. May give examples of children having sex or imply many of their peers are sexually active. May glamorize sex, use graphic materials, teach explicit sexual vocabulary, or encourage discussion of sexual experiences, attractions, fantasies or desires,

2. TEACHES CHILDREN TO CONSENT TO SEX

May feach children how to negotiate sexual encounters or how to ask for or get "consent" from other children to engage in sexual acts with them.

3. NORMALIZES ANAL & ORAL SEX

introduces these high-risk sexual behaviors to children and may normalize them. May omit vital medical facts, such as the extremely high STI rates (i.e., HIV and HPV) and oral and anal cancer rates associated with these risky sex acts.

4. PROMOTES HOMOSEXUAL / BISEXUAL BEHAVIOR


Promotes acceptance of and/or exploration of diverse sexual orientations, sometimes in violation of state education laws. May omit vital health information and/or may provide medically inaccurate information about homosexuality or homosexual sex.

5. TEACHES CHILDREN SEXUAL PLEASURE

Teaches children about sexual pleasure. May tell them they are entitled to or have a "right" to sexual pleasure or encourage children to seek out sexual pleasure.

6. PROMOTES SOLO OR MUTUAL MASTURBATION

While masturbation can be part of normal child development, encourages masturbation at young ages. making chicken more vulnerable to pomography use, sexual addictions or sexual exploitation. May describe masturbation or provide instruction on how to masturbate. May encourage children to engage in mutual masturbation.



7. EROTICIZES CONDOM USE

May use sexually explicit methods (i.e., penis and vagina models, seductive role play, etc.) to promote condom use to children. May provide medically inaccurate information on condom effectiveness and omit or deemphasize failure rates. May imply that condoms will provide complete protection against pregnancy or STIs.

8. PROMOTES EARLY SEXUAL INDEPENDENCE

Teaches children they can choose to have sex when they feel they are ready or when they find a trusted partner. Fails to provide data about the well-documented negative consequences of early sexual debut.

9. FAILS TO ESTABLISH ABSTINENCE AS THE GOAL

Fails to establish abstinence (or a return to abstinence) as the expected standard for all school-age children. May mention abstinence only in passing. May teach children that all sexual activity—other than "unprotected" vaginal and oral sex is acceptable, and even healthy. May present abstinence and "protected" sex as equally good options for children.

10. PROMOTES GENDER CONFUSION

Promotes affirmation of and/or exploration of diverse gender identities. May teach children they can change their gender or identify as multiple genders, or may present other unscientific and medically inaccurate gender ideologies. Fails to teach that most gender-confused children resolve it by adulthood and that extreme gender confusion is a mental health disorder (gender dysphoria) that may be helped with therapy.

11. TEACHES ABORTION / CONTRACEPTION

Presents abortion as a safe or positive option while omitting data on the many potential negative physical and mental health consequences. May teach children they have a right to abortion and refer them to abortion providers. May encourage the use of contraceptives, while failing to present failure rates or side effects.

12. PROMOTES PEER-TO-PEER SEX ED / SEXUAL RIGHTS ADVOCACY

May train children to teach other children about sex or sexual pleasure through peer-to-peer initiatives. May recruit children as spokespeople to advocate for controversial sexual rights (including a right to CSE itself) or to promote abortion.

13. UNDERMINES TRADITIONAL VALUES AND BELIEFS

May encourage children to question their parents' beliefs or their cultural or religious values regarding early sex, sexual orientation or gender identity.

14. VIOLATES OR UNDERMINES PARENTAL RIGHTS

May instruct children they have rights to confidentiality and privacy from their parents. May teach children about accessing sexual commodities or services, including abortion, without parental consent. May instruct children not to tell their parents what they are being taught about sex in school.

15. REFERS CHILDREN TO HARMFUL RESOURCES

Refers children to harmful websites, materials or outside entities. May also specifically refer children to Planned Parenthood or their affiliates or partners for their lucrative services or commodities (i.e., sexual counseling, condoms, contraceptives, gender hormones, STI testing and treatment, abortions, etc.)

Public Records Requests Submitted

Two requests were made to the Ohio Department of Education with the following responses:

March 28, 2018

Ms. Stover, I am writing to acknowledge receipt of and respond to your public records request in which you requested "a list of all sex education curriculum for all K through 12 classes for all school districts in Ohio and categorized by district alphabetically."

The Department does not have a responsive list. Ohio law (ORC 3301.0718) does not permit the State Board of Education to adopt Health Education Standards in Ohio. However, Ohio law (ORC 3313.60) requires each district to adopt a course of study including certain designated subjects, such as health education, which shall include instruction in venereal disease and dating violence prevention education.

Dear Mr. Stover: This email serves as the response to your public records request. There are no public records that are responsive to your request. It should be noted that the State Board of Education is prohibited from adopting or revising any standards or curriculum in the area of health unless there is a concurrent resolution approving such standards or curriculum that is approved by both houses of the General Assembly pursuant to Ohio Revised Code 3301.0718.

Additionally, the prescribed curriculum for health education is the responsibility of local boards of education pursuant to Ohio Revised Code 3313.60.

Public Records Request Submitted with the Following Response August 21, 2018

Ms. Stover: We have been working on your request. I have the following information to provide at this time. I will also need additional clarification. Correspondence regarding the grants" - We do have email communications with sub-grantees, community partners, and our HHS project officer regarding implementation, evaluation, and reporting

First, the opening paragraph of your request asks for a "list" of all Sex Education Curriculum for K-12, all schools in CMSD and categorized by district alphabetically. While we do not have or keep a document that compiles a list as requested, we thought it appropriate to create a list and provide that to you as a start. Please see the attached document.

According to the attached list and the programs/grants indicated thereon, based on your request our agency has no information related CMSD. In your response to my first inquiry, you indicated that you were seeking information related to all school districts in Cuyahoga County. So, the attached is in response to your request in paragraph one of your letter as clarified. Please confirm that we have complied with this requested item.

Your third paragraph request is vague and overly broad and/or needs further clarification. You requested "information" regarding the grants identified. What type of information are you seeking?

Also, in your third paragraph you requested "supplemental materials" funded through those grants. Please clarify what specifically you are referencing in the phrase "supplemental materials".

Your fifth paragraph requests all emails and communications with school districts. Our agency sought and received support letters from the school entities listed in the attachment to support the grant application. So, we would have the actual support letters. I believe most communications took place between the third party organizations that provided the services and the school districts as opposed to our staff having email communications with school staff or officials.

If your request will ultimately include copies of any of the curriculums and/or materials that are listed in the attachment, I am certain that the cost will well exceed \$100. Our agency will not issue a waiver of costs and/or fees. Many of the materials are bound. We would have to send it out for copying at your expense which funding will have to be provided up front. There are a number of videos which would all have to be copied commercially, all at your expense. I do not have an estimate but suffice it to state that the cost could end up well over \$1000.00.

We would be happy to make these materials available for inspection rather than copying. Please review the attached and the information provided above and feel free to contact me at your convenience.

Ms. Storer: Please see my responses to your questions as follows:

A few questions about the list you created:

- 1. Is the list a start or is it a full and complete list of all locations? This is complete list of all locations.
- 2. In the list, under "service locations," are all of the PREP programs only "foster/juvenile" programs located in the various counties listed? Yes, Ohio PREP is implemented only in foster & Juvenile facilities.
- 3. Under TPP programs, are the "service locations" the names of High Schools? These are the names of the School Districts. Our TPP program serves the middle and high school in these districts. I am surprised that there is no information about the Cleveland Metropolitan School District (CMSD). You have no information about Sex Education curriculum for the Cleveland Public Schools for pregnancy prevention or HIV prevention similar to the other service locations you listed? Why would there be no information for Cleveland? We do not provide TPP services in CMSD schools.

Correspondence regarding the grants" - We do have email communications with sub-grantees, community partners, and our HHS project officer regarding implementation, evaluation, and reporting.

Regarding your question about supplemental materials I was referring to curriculum books and the supporting materials to those books including videos. In addition to curriculum, We do have supplemental resource material created in house. It is not a part of our curriculum.

Will you be scanning and sending us the support letters? I will gather the support letters, have them scanned and send those to you by sometime this week.

Given your explanation of costs we would not want to incur a large expense over \$100 for these materials and therefore yes, we would like to inspect. As we are inspecting, would it be possible for us to make copies of the materials at your site? Copies can be made for you by our staff but only the first 20 pages of copies are free. After that, we are required to charge 5 cents per page and payment would have to be made up front. Or, you are free to bring your own copier, within reason (doesn't interrupt our staff, take up space from our normal business practices, etc.). Materials will not be permitted to be taken off site out of our control.

I gather from your request that you are seeking information on this topic regarding CMSD. Generally, CMSD is not within our jurisdiction. Our agency does not provide any services on this topic to CMSD.

If you desire to conduct an inspection, please contact me to make such arrangements. If based on my responses to your additional comments you desire to request copies of any of the materials, please advise.

III. Planned Parenthood Advocacy and Education Report

- Through the FCFC grant, PP facilitated the Get Real curriculum for over 900 middle and high school students in CMSD.
- The Making Healthy Decisions Project study with Carnegie Mellon culminated with four sessions in Cleveland.
- The Peer Ed program wrapped up in May. The youth held over 1k conversations with their peers in 4 different counties.





Currence County Counce says money for pre-K education should go to existing program | cleveland.com

The <u>pre-K initiative</u> is a priority of Budish, who has said \$10 million would be added to money the county already puts toward pre-K education, with a focus on improving and expanding the programs and bolstering enrollments. The money, which officials said would be matched by private and foundation funds, would be administered by a new Cuyahoga County Early Childhood Trust.

Universal pre-K started with 1,000 children nine years ago and 2,300 are currently in the program, with 75 percent receiving scholarships to cover costs, Dorman said. Since the program began. Dorman said, it has received \$26 million in private funding and a two-year \$500,000 grant and three-year \$1 million grant from the Gund Foundation.

In response to questions. Dorman said additional pre-K funds would allow her department to expand the program without major administrative costs.

Council member Pernel Jones said he considered Invest in Children a respected organization and believes it should administer the funds.

Council member Yvonne Conwell asked "Why are we creating something new?"

Council member Jack Schron agreed and said Invest in Children would not have to start from scratch.

"It seems to me we are reinventing the wheel," he told Dorman. "I hope when you get in that room, you speak with a loud voice."

Council members were surprised when Dorman said she had attended an all-day retreat on the proposed pre-K program that was led by a consultant with the <u>Build Initiative</u>, which supports early childhood development.

A county official later said the consultant did not charge for her appearance because she is working on the initiative in Ohio.

Council members said they support funding pre-K programs, but were concerned about the 24 percent budget cut to un Family & Children First Council Which works with older children

The proposed reduction from \$4.75 million in 2015 to \$3.6 million in 2016 includes \$500,000 for an after-school program.







OUR ACCOMPLISHMENTS

The Collaborative

Founding

The Collaborative grew out of a gathering convened in 2005 by the George Outo Foundation of all known local organizations and several key national organizations—providing or supporting adolescent reproductive health care. The purpose was to identify entities committed to the concept of comprehensive sexuality education and catalyze support for local and state policies and programs promoting a comprehensive sexuality aducation philosophy. Altendees discovered two surprising things that day: (1) many organizations were unfamiliar with each others' work in this area, and (2) Cuyshogs Gounty had been supporting a non-evidence based abstinence-only-until-marriage curriculum (AOUM) in some local school districts with state. Welfness Block Grant funds. As a result of that meeting, participants quickly agreed that an ongoing forum was needed to systematically advance the provision of comprehensive sexuality education to youth across northeast Ohio. Thus, the Collaborative was born, it has been meeting quarterly as a professional network.

Marcia Egbert of The George Gund Foundation currently serves as Chair. Administrative and staff support is provided by the Center for Community Solutions. Public policy and program support is provided by Shalina Munoz, Coordinator.

Accomplishments

The Collaborative worked closely with senior Cuyahoga County elected and appointed officials and leadership of the Cuyahoga County Board of Health to promote and ensure a smooth transition away from any funding for abstinence-only-unit-matriage programming. In partnership with the Board of Haster and school districts which selected comprehensive programming, the Collaborative heliped demonstrate the strong community support behind such a transition. With the Collaborative's direct support, Cuyahoga County adopted the practice of limiting use of funds to comprehensive, abstinence-inclusive curricula in 2006.

A restural next arens for engagement for the Collaborative was with the Convellent Metropolitan School District (CMSD), given its status as the largest school district in northeast Ohio and its existing policy requiring comprehensive sexuality education curricula. The Collaborative's goal was to expand provision of comprehensive sexuality education in the CMSD beyond the targeted grade levels where curriculum was provided in 2005 to reach all children in grades K-12.

Potentially catalytic opportunities to achieve this goal emerged through the interest and leadership of Gleveland Mayor Frank Jackson and the Cuyahoga County Commissioners in 2006. The Collaborative worked to coordinate these opportunities in a menner-likal resulted in a financial commitment by the County to underwrite expansion to universal availability of comprehensive sexuality education in the CMSD beginning with the 2006-07 school year. Once that commitment was made, the Collaborative quickly worked with CMSD leadership to organize the technical support needed to identify and craft the necessary curricula. Additionally, the Collaborative worked to secure a highly regarded external evaluation partner (Philliber Research Associates) to evaluate the model and provide critical data that supports the continuous improvement of the CMSD program. The effective conduct of this on-going availuation would not be possible without the leadership and expertise of the AIDS Funding Collaborative, which serves as the evaluation monitor. CMSD has been a remarkable leader in this initiative, but its effort would not be sustainable without



The cost to schools of these provisions will vary depending on whether they are offering this type of education currently and whether they are able to adapt existing free or low-cost resources to develop the required curriculum and in-service training The U.S. Centers for Disease Control and Prevention offer free resources on HIV/AIDS prevention, although their current resources targeting youth focus on abstinence and may not meet the requirements of the bill. Local departments of health may also be willing to partner with schools in providing training and other resources. In addition to government agencies, many national and local nonprofit organizations may also serve as low-cost resources for schools.

The Cleveland Metropolitan School District in Curyahoga County offers a program called "Responsible Sexual Behavior Curriculum Delivery," which likely exceeds the requirements of the bill, but provides one example of the costs of a related program in a large urban school district. Cleveland's program provides comprehensive health education regarding sexually transmitted diseases, teen pregnancy prevention. and related areas to all students in kindergarten through 12th grade. Among this program's several initiatives is one that offers HIV/AIDS education in grades 7 through 12. The program is a partnership between the school district, the city, the county board of health, and several charitable foundations. Last school year the program operated at just under \$500,000 from grant funding. The \$500,000 provided funds for three program staff, outside consultants, and program evaluation.

Cleveland's program likely provides an upper limit on the cost of the bill to a school district. The cost to most school districts will be much less as districts should be able to meet the bill's requirements through a less extensive program. In addition, districts such as Cleveland that may already be meeting the bill's requirements will have no additional cost as a result of the bill.

Additionally, we have added some pages of separate reports that validate that Comprehensive Sex Education Curriculum is being used in the Cleveland Metropolitan School District. There is too much information to include all pages.



Abstract

Name: Preventing HIV/AIDS through K-12 Responsible Sexual Behavior (RSB) Curriculum Education

Description/Purpose: The Cleveland Metropolitan School District (CMSD) seeks funding to sustain collaborative support of the RSB Program for the 2014-2015 school year. The overarching goals and objectives are to prevent HIV/AIDS, sexually transmitted diseases and unintended pregnancy through rigorous classroom instruction. CDBG funds are used to support RSB program staff (Solution Specialist). This position, is an externally funded school district position, and is part of the framework for Cleveland's Plan for Transforming Schools.

Funding Priority Addressed: In 2010, young people ages 13 to 24 accounted for 21% of all new HIV infections in the United States. Nearly half of the 19 million new STDs reported each year are among young people ages 15 to 24. Well-planned and implemented comprehensive school health education has been shown to positively influence students' health-related knowledge, skills and behaviors.

HIV Prevention Service Gaps: The CMSD K-12 Responsible Sexual Behavior Program is the only comprehensive sexuality education program of its kind in the state of Ohio. Infan attempt to ensure all CMSD students receive equitable, quality intervention education, the District has partnered with The Cleveland Department of Public Health and the Cuyahoga County Board of Health, to provide comprehensive sexuality education to CMSD students in grades, K-12. Organizational Commitment to HIV Prevention

Historically, various health and social service agencies have provided services and educational programming in several Cleveland schools. This was done on a sometimes random and inconsistent basis, with agencies relying on relationships with individual principals and/or schools, rather than forging system-wide partnerships at the administrative level. In order to stabilize services and improve quality, the Cleveland Metropolitan School District began seeking ways to form more strategic community partnerships. Engaging with community service leaders at a systems level requires carefully coordinated activities and precise levels of communication from schools and their partners. Initiating these practices district-wide eliminates duplication of services, and ensures programming that is consistent with academic goals and objectives. The expansion of the K-12 Responsible Sexual Behavior Initiative demonstrates eight years of integrating these practices into HIV/AIDS prevention programming.

The Cleveland Metropolitan School District provides free, public education to approximately
40,000 students each year. The District provides meals free of charge to 96% of those students,
via the Federal School Lunch Program. The District also provides a continuum of services to
students, including nursing services, mental health counseling and special education services and
health screenings and assessments in certain cases. The Cleveland Metropolitan School District
serves as a conduit between community health services and students and families. The District
remains committed to fostering and maintaining these relationships and supporting the overall
lealth and well-being of its students and families.

Target Population

All Cleveland Metropolitan School District students, their families, and the District's staff are explicitly targeted for prevention and intervention around the indicator area of Responsible Sexual Behavior, including HIV/AIDS. Whether targeted for greater access to and understanding of available services, education, outreach, or to decrease risky behavior, all students, families, and staff require targeted prevention and intervention efforts. The District is uniquely positioned in the community to reach large numbers of student, families, and staff. Working in conjunction with key partners, the District will ensure that this population is reached.

Data on the behavior of students in the Cleveland Metropolitan School District is collected biannually through the Youth Risk Behavior Survey (YRBS), which is administered in evennumbered years in middle schools and odd-numbered years in high schools. The following
recent results (2012/2013) demonstrate the need for comprehensive prevention and intervention
around sexual behavior and disease prevention, including HIV/AIDS for students in the
Cleveland schools.

- 33.1% of middle school students surveyed reported having had sexual intercourse.
- 60% of high school students surveyed have had sexual intercourse
 44% of high school students surveyed reported being sexually active
- 24% of high school students surveyed reported having had 4 or more partners
- 5.7% of high school students surveyed reported having had sexual intercourse prior age of 13 (compared to 6% in Ohio and 7% in the United States).

Evaluation

A critical element of the District Wellness Policy is that the goals and objectives set forth are measurable. Evaluation is a natural and imperative component of everything related to the Plan. The Youth Risk Behavior Survey (YRBS) is the main long-term evaluation tool for the Plan. The test is administered every other year to middle and high school students. Middle school students receive the test in even numbered years and high school students in odd numbered years.

In addition to the YRBS, though, many process measures will also be used. Curricula used are evidence-based, and have already been tested to measure their effectiveness. Also, as part of the Cuyahoga County Board of Health's Expanded Teen Wellness Initiative, an evaluation component has been included for the 6-12 curriculum delivery. This year's program evaluation is being provided by Case Western Prevention Research Center for Healthy Neighborhoods. Components of the evaluation have include:

- Pre and Post testing of students
- Focus groups involving program facilitators, classroom teachers, and parents.
- Observation and Feedback of program facilitation, both internal and external providers.

By participating in the YRBS conducted every other year in CMSD in middle and high schools in alternating years, the District hopes to be able to measure behavior change as it pertains to sexual risk behavior. Expected outcomes as measured by both the program evaluation and to YRBS include but are not limited to:

- · Reduction in premature sexual activity
- · Reduction in the number of sexual partners
- · Increase in awareness of sexual and reproductive health resources for students



EXECUTIVE SUMMARY

The Responsible Sexual Behavior Initiative, which was implemented in the Cleveland Metropolitan School District (CMSD) beginning in the Fall of 2006, aims to provide comprehensive sexuality education to all students from kindergarten through twelfth grade within the school district. Four evidence-based curricula were chosen specifically for this initiative. During the 2007–2008 school year, modified versions of these curricula were implemented by facilitators from six contracted agencies and 11 trained CMSD health and physical education (PE) teachers. The four curricula are:

- All About Life (for grades K-3)
- · F.L.A.S.H. (for grades 4-6)
- · Making Proud Choices (for grades 7-8)
- · Safer Choices (for grades 9-12)

The AIDS Funding Collaborative (AFC) contracted with Philliber Research Associates (PRA) in November 2007 to conduct the 2007-2008 (Year 2) evaluation. Progress Toward Implementation of the Initiative

During the 2007-2008 school year, 41,442 students are offere were assigned to receive the curricula. A total of future in 26,326 of these assigned CMSD students in grades K-12 actually received programming during the 2007-2008 school year. This represents 64% of the students targeted by the initiative in Year 2. Barriers to curriculum delivery included lower than anticipated involvement of previously trained teachers, late funding and subsequent execution of contracts with external agencies, scheduling conflicts, and late start-up of the evaluation process which resulted, in some cases, in delay of curriculum delivery.

Currently, Health and Physical Education do not have academic content standards. Ohio State Board of Education is not allowed to adopt Health Education Standards http://codes.ohio.gov/orc/3313.60, but requires districts to teach content including: natural and organically produced foods; drugs of abuse, alcoholic beverages and tobacco; venereal disease (*parent exemption); personal safety and prevention (K-6), sexual violence prevention (7-12); First Aid (now including CPR & AED http://codes.ohio.gov/orc/3313.6021); prescription opioid abuse prevention; anatomical gifts.

Using the National Standards of Health Education and the Ohio Revised Codes pertaining to Health Education, the Physical Education and Health Wellness Curriculum Council made of Cincinnati Public School teachers in these areas are concluding on an adoption year to develop curriculum and resource adoption for the Cincinnati Public Schools Board of Education to consider and vote on. Currently there is no adopted curriculum or resources for grades K-8. Senior High Health, grades 9-12 has no adopted curriculum, but uses the 2011 adopted resource of Glencoe Health, published by McGraw





GENERAL PROGRAM DESCRIPTION - STEP STRONG

The STEP STRONG Program is a two-day, fast-paced, interactive presentation that is currently presented in 7° grade health classes. The program focuses on choices and challenges facing teens in many areas.

Day One of the presentation centers around the topic of choices regarding sexual involvement. Frank conversation takes place about STD's, condom failures, media and peer pressures.

Day Two is filled with conversation regarding the importance of setting goals, choosing friends and who teens surround themselves with, listening to positive versus negative influences, refusal skills, acknowledging stress, ways to better handle stress, and reaching out for help.

Although both days touch on different challenges that students may face, they are often reminded in the presentation that they have "rights", the backbone of this prevention program – specifically, the right to be SAFE and the right to be STRONG. The program hopes to get the student to acknowledge those rights, embrace the fact that they should feel both, and then feel empowered to rely on those rights to make healthy choices in the many areas discussed in the program and beyond.

Students are asked to complete an anonymous evaluation form at the end of Day Two. Below is a small sampling of the type of comments that are received at every school:

"This program really helped. I know who my true friends are. I really take this to heart because I was being asked to do things that I'm not ready for, but I'm going to wait til I'm ready."

"Your program really helped me a lot because I have problems and you really helped me to think on my life and thoughts."

"My favorite part is that they explained how to make good choices and help other people if they are stressed or depressed."

"This was a really good program experience for me. It made me think about a lot of decisions I have to make and decisions I've made and I'm really thankful for that."

Teachers also share an evaluation form. Below is a sampling of teacher comments:

"Very relevant material and presented in a way where kids felt comfortable. This program MAKES the students THINK about their future. Well done!"


