Blodgett Peak Open Space BioBlitz Saturday, August 6, 9:00 AM - 2:00 PM

Green Mountain Musk Thistle Removal Work Day Sunday, August 7



We will be revisiting our 2011 restoration project site in the Green Mountain Roadless Area, just east of Lost Creek Wilderness, to remove more invasive musk thistles.

The work will take most of the day and participants will traverse several miles in the Green Mountain backcountry. Bring work clothes, heavy work gloves (thistles are sharp), and footwear suitable for walking on an abandoned roadway.

The Colorado Wilderness Act passed the House!

On July 14, the US House passed the Protecting America's Wilderness and Public Lands Act (PAW+) as part of the defense bill! This once again includes the Colorado Wilderness Act that would establish over 660,000 acres of wilderness protections on Colorado public lands! More info [here](#).

BLM Colorado Big Game Resource Management Plan August In-Person and Virtual Meetings Public Comments due September 2.

On July 19, the BLM began scoping on their Colorado Big Game Resource Management Plan Amendment.

The BLM will hold three in-person meetings: Aug 8 in Colorado Springs, Aug 11 in Grand Junction, and Aug 12 in Montrose. There will also be virtual meetings on Aug 3 and 4. Public comments are due Sept 2.
