# Archdiocese Plans Pre-K Language

Mayor Lori E. Lightfoot announces the return of the annual Chicago Auto Show to McCormick Place from July 15th to 19th and will be held indoors and outdoors for the first time.

Among the safety measures in place: a move to Hall F in West Building with 470,000 sq ft of indoor space and 100,000 sq ft of outdoor space; timed entrance windows and staggered entry to prevent congestion on the show floor; contactless delivery for tickets; temperatures will be scanned and a medical questionnaire must be filled out before entry.

Statewide, 55 percent of individuals 16 and over and 79 percent of individual 65 and over have been vaccinated, helping bring down increases in new COVID-19 cases and hospitalizations. As these metrics continue to stabilize and decline, the state could soon move into the "Bridge Phase" of the Illinois Restore Reopening Plan. 
