Pee Wee Class!!!

Pee Wee Class - The Pee Wee Special Attraction is a Pre-Junior Showmanship class. The Pee Wee class is for children over 5 years & under 9 years of age. Safety is a primary concern.

Each Pee Wee unit consists of: the child; his/her parent or guardian or responsible adult; and their dog. Only one Pee Wee unit is in the ring at a time. This is not a competitive class, but rather a fun, learning experience for the child and the adult.

- The dog must be at least four months of age to be entered in the Pee Wee class.
- Bitches in season will not be allowed to participate. If pre-entered, a dog may be substituted that meets the eligibility requirements as specified by the club.
- All dogs entered must have the proper lead and collar.
- A responsible adult must be present with the child both inside and outside the ring.
- All AKC fully recognized and Miscellaneous group breeds are allowed to enter, including dogs with a PAL listing, as well as FSS breeds not in the Miscellaneous group and All-American dogs. Dogs need not be AKC registered to participate.
- Mixed breeds are welcome.
- Officiating Judge will be Mr. Lawrence C. Terricone.
