Adults are familiar with FDR's speech before Congress where he called December 7, 1941 A Day of Infamy. Many of us know the story. Even those who crab all the time understand just how good, we got it.

Cats, Swamp, Feathers and Scales, Reptiles and Birds, Living Coast, Hamill Family Wild Encounters, Seven Seas underwater viewing gallery, Great Bear Wilderness, Australia House (front section only), and Hamill Family Play Zoo, will be open. Dolphins in Action presentations (extra fee applies) are at 4 and 6 p.m. each night.

Kids can deposit their written greetings and drawings for the animals in a designated box, and drop off letters to Santa Claus in a giant red box, on the South Mall.

Guests can take a spin on the skating rink, which is made of synthetic plastic. The cost for unlimited time for skaters on the rink is \$7. A limited number of skates are available to rent for \$5 fee.

Reservation times are available in 15-minute increments. Zoo admission and parking tickets, which must be reserved in advance at CZS.org/HolidayMagic, are \$24.95 for adults, \$17.95 for children ages 3-11, and \$19.95 for seniors 65 and over. Parking is \$15.

Outdoor Ice Rinks Open For Season



The Chicago Park District's outdoor ice skating rinks are open through Feb. 21st, weather permitting. The ice skating ribbon at Maggie Daley Park, 337 E. Randolph st., is open through March 13th.

Timed-reservations will be required at www.chicagoparkdistrict.com/ice-rinks. In accordance with Covid-19 social distancing guidelines. Pre-registration is required for all programs, including open skate sessions. Registration will be released on a rolling basis at noon on Mondays, for the sessions that run two weeks later. Skaters can check in 30 minutes before the start of their scheduled session.

Skaters who bring your own skates can reserve a free skate spot. Skate rentals will be available for \$7 in child's size 8 through men's size 12. Half sizes are not available.

In addition to open skate, most ice rinks will feature programming including drop-in learn to skate lessons, stick & puck plus pond and rat hockey. Locations are: McKinley Park, 2210 W. Pre-registration is required for all programs. Open Skate is open to all ages. Pre-registration is required and admission is \$7.

Drop-In Learn to Skate Lessons provide instruction on the basics

of balance, forward stride, starting, and stopping. Recreational or hockey helmets, gloves and knee pads are recommended. Admission (includes skate rental) is \$10.

Stick & Puck and Pond Hockey offers 45-minutes of Stick & Puck followed by 45-minutes of Pond Hockey for one price. Players will be required to wear a helmet, shin pads, cup and hockey gloves. Skaters must bring their own equipment, including hockey stick. Admission (includes skate rental): \$8 person, \$10 for adult & child

Stick & Puck offers open access to the ice for practicing stickhandling, skating and shooting skills.

Pond Hockey Practice for non-contact battling up to 5-on-5 skaters. The program is open to children and adults and is offered in combination with the Stick & Puck program.

Rat hockey is a pick-up game available for players 18-years-old and older. All players will be required to wear a helmet, shin pads, cup and hockey gloves. If eight participants are not registered, the program will be canceled. Admission (includes skate rental) is \$10.

Sled-assisted skating allows people of all abilities to skate together. These specialty sleds for both children and adults are designed with a foot guard, ABS bucket seat, footrest, and pusher handle. No usage charge. Reservations are required at (312) 442-2194.

The zoo's 40-foot x 80-foot skating rink is not made of ice, but of a synthetic plastic known as Glice®, a material composed of heat-pressed layers of polymers, so no water or electricity is required for operation.

The cost for unlimited time for all skaters is \$7. A limited number of skates are available to rent for a \$5 fee. Skaters are welcome to bring their own skates.

Create the ultimate winter outing and venture to Brookfield Zoo on one of its remaining Fall Free Days, presented by Xfinity—December 6th-7th, 13th-14th, and 20th-21st. Many of the zoo's cold-hardy animals, including the snow leopards, Bactrian camels, bison, Amur tiger, Mexican wolf, and Amur leopard can be seen in their outdoor habitats. Stop around Roosevelt Fountain to view the more than 700 community and corporate decorated trees.

Kirk's Dik-dik Birth At Brookfield Zoo

A Kirk's dik-dik, one of the world's smallest antelopes, was born at Brookfield Zoo on Oct. 13th. At birth, male calf weighed just over 1½ pounds and is currently behind the scenes with his mother, Buttons. Animal care staff set up a GoPro camera to get video of the newest addition to share with the public. It can be viewed on the zoo's social media channels.

There is a nest site, where the newborn remains hidden for 10 to 20 days and will nurse for about three to four months. Weaning is attained when the calf reaches a weight of about 4 pounds. Once full grown, the male can weigh up to 14 pounds and measure 14 to 16 inches tall at the shoulder.

This small antelope, native to Africa's Kenya, Somalia, Tanzania, Angola, and Namibia, got its name from the sound it makes when threatened as well as after Sir John Kirk, a 19th century Scottish naturalist. Its coat varies in color from a yellowish-gray to reddish-brown.

The species can be identified best by its large, striking, dark eyes that are surrounded by a white ring. Only the males grow short corrugated horns. The elongated snout allows a dik-dik to help keep cool by rapidly panting to cool

1,009 Homicides For Cook County

The Cook County Medical Examiner's Office confirmed the 1,000th homicide in 2021 over the holiday weekend. The total, with more than a month left in the year, stands at 1,009. In 1994, the County recorded 1,141 homicides. In 1991, the Office handled a record 1,229 homicides.

This year, African Americans were the victims of 81% of homicides and Latinos accounted for just under 15% of homicide deaths. 88 percent of homicide deaths were male. The Office confirmed 986 homicides in 2020 and 675 in 2019.

The Office has confirmed 777 homicides in Chicago this year. Municipalities with the most homicides this year are: Harvey with 30, Maywood - 16, Dolton - 11, Calumet City - 8, South Holland - 8, Berwyn - 7, Chicago Heights - 7, Cicero - 6 and Markham - 6.

The youngest person killed in Cook County was a 1-month-old boy, and the oldest was an 84-year-old man.
