**CONSTITUTION**

DAVISS – MCLEAN BAPTIST ASSOCIATION, INC.

Organized on November 1 – 3, 1844 Approved on October 9, 1989 Revised on November 19, 2020

**PREAMBLE**

In order to promote our common interest and spiritual and material well-being; strengthen our bonds of fellowship and unity; extend the cause of world missions; promote biblical stewardship; and combine our energies and talents to execute the will of our Lord Jesus Christ;

We, the Baptist churches of Jesus Christ in the Association, declare and establish this Constitution.

**ARTICLE I. NAME**

The name of this body shall be the DAVISS – MCLEAN BAPTIST ASSOCIATION, INCORPORATED.

**ARTICLE II. PURPOSE**

Section 1 – Among the Churches. To further the Kingdom of God, the purpose of the Daviess – McLean Baptist Association is to enable its churches to be in Christian fellowship and to be on mission individually and collectively in their settings.

Section 2 – Within the Denomination. The Association shall further seek to facilitate the exchange of information and opportunities for cooperation between the affiliated churches and the Kentucky Baptist Convention, the Southern Baptist Convention, and their agencies.

### **ARTICLE III. AUTHORITY**

Section 1 – A Southern Baptist Association is a fellowship of autonomous churches sharing a common faith and being active on Mission.

Section 2 – This Association shall exercise no ecclesiastical authority over its constituent churches; nor shall it interfere with their independence or internal affairs.

Section 3 – Being simply an advisory body, the Association may only advise, recommend, and encourage the churches to perform maximum obedience to Jesus Christ.

### **ARTICLE IV. MEMBERSHIP**

Section 1 – Statement of Membership. The Daviess – McLean Baptist Association shall consist of messengers who are members of the Baptist Churches which freely enter into covenant relationship with one another under the Lordship of Jesus Christ, which affirm a common statement of faith ACCORDING TO THE 2000 BAPTIST FAITH AND MESSAGE, which subscribe to the Constitution and By-Laws, which annually send letters of report to the Association and which share in the work of the Kingdom of God through the Association.

Section 2 – Affiliation. A Baptist church desiring affiliation with the Association shall meet the following conditions:

- a. Each church desiring affiliation with the Association shall petition the Association for membership at least 90 days before the annual session of the Association.
- b. The petitionary letter shall include a copy of the Church's Article of Faith, Church Covenant, Rules of Decorum or Constitution, and the name of the member church of the Daviess-McLean Baptist Association which is willing to recommend the petitioning church for membership in the Association.
- c. The Credentials Committee composed of the officers of the Association, shall investigate the petitioning church to determine if it is sound in doctrine, orderly in constitution and practice, and sympathetic with the purpose and work of this body. Upon completion of its investigation, and upon receipt of a written communication from a member church in the Association directed to the Credentials Committee which recommends the petitioning church for membership, the Credentials Committee shall make a report and recommendation to the Association as to its findings.
- d. The petitioning church may only be received into full fellowship by a two-thirds majority vote of the messengers present and voting during the Association's annual session.

Section 3 – Messengers and Members. This Association shall meet in sessions which shall be composed of messengers and members, as defined below.

- a. Each church of the Association shall be eligible to choose from its membership three (3) messengers for the first fifty members of the church or fraction thereof, plus an additional messenger for each additional fifty members or major portion thereof, provided that no church shall be entitled to more than ten (10) messengers under the subsection.
- b. Each church of the Association shall be entitled to send, as an additional messenger, its pastor or other ordained minister who is a minister in, or member of, the church.
- c. All ordained ministers who are members of churches in the Association but who are no longer in the pastorate by reason of retirement taken before the adoption of this Constitution shall be members of this body, and be entitled to vote in sessions. All such ministers who are no longer in the pastorate by reason of retirement taken on or after the adoption of this Constitution shall be emeritus members of this body with all the rights and privileges of membership except the privilege of voting during sessions unless otherwise duly appointed as a messenger under subsections a. or b. above.
- d. Full-time employees of the Association shall be ex officio members of this body with all the rights and privileges of membership except the privilege of voting during sessions unless otherwise duly appointed as a messenger under subsections a. or b. above.

Section 4 – Statement of Faith. The statement of faith adopted by the Southern Baptist Convention meeting in Atlanta in 2000 and known as “The Baptist Faith and Message” shall be the ground of common faith and practice for the Association.

Section 5 – Association Reports. The annual reports shall be recorded in the SBC Database by September 15, containing such information as is requested on the Annual Church Profile in general use among the churches affiliated with the Kentucky Baptist Convention and Southern Baptist Convention.

Section 6 – Withdrawal of Affiliation. The Association shall have the power and right to withdraw affiliation from any member church which it may deem to be unorthodox in doctrine, disorderly in conduct, or negligent in reporting to this body for two consecutive years. After proper efforts to reclaim the church have been taken by the Credentials Committee, the Executive Board may recommend withdrawal of affiliation to the Association. A two-thirds majority vote of the Association in session shall be required to withdraw affiliation from a church.

## **ARTICLE V. MEETINGS**

Section 1 – Annual Session. The Association shall conduct a two-day annual session beginning on the second Monday in October, unless otherwise determined by the Executive Board, at such times and places as agreed upon by the Association.

Section 2 – Special Session. The Executive Board may, upon majority vote, call a special session, provided that a fifteen-day notice has been given in writing to the churches, stating the purpose of the special session.

## **ARTICLE VI. OFFICERS**

Section 1 – The officers of the Association shall be the Moderator, First Assistant Moderator, Second Assistant Moderator, Clerk, and Assistant Clerk. The officers shall be elected at the first meeting of each annual session and shall serve during the ensuing year and the following annual session. The Moderator shall not be eligible to serve two consecutive terms.

Section 2 – The Association shall have six (6) Trustees, serving terms of three years in rotation. Two (2) shall be elected at the first meeting of each annual session, upon nomination by the Nominating Committee, to serve three years. These trustees are to hold title to and have charge of all physical properties for the Association. They may expend on upkeep and repair up to the amount authorized by the budget or by special action of the Executive Board.

## **ARTICLE VII. EXECUTIVE BOARD**

The Association shall have an Executive Board which shall carry on the work of the Association between sessions. The board shall always act in strict accordance with the Constitution of the Association, fully respecting the autonomy of the churches and their rights in the Association.

Section 1 – Officers. The officers of the Association shall serve as officers of the Executive Board.

Section 2 – Membership. Membership of the Executive Board shall consist of:

- a. Two representatives and two alternates from each church, elected annually by each church. In the case of a vacancy, the church shall notify the Association in writing prior to the day of the Executive Board meeting, giving the name of the new board member.
- b. The pastor of each church in the Association. In the event the church is without a pastor, the church may designate an additional representative to attend the Executive Board meetings. The church shall notify the Association in writing prior to the day of the Executive Board meeting, giving the name of the additional representative.
- c. The officers of the Association.
- d. All Chairpersons of standing Administrative Committees and directors of Mission Performance Program Units.
- e. No full-time employee of the Executive Board shall be recognized as a voting member.
- f. No full-time or part-time employee may be elected to any Associational Administrative Office.

- g. All ordained ministers who are members of churches in the Association, but who are no longer in an active pastorate due to retirement taken before the adoption of this Constitution shall be entitled to all privileges as Executive Board members. All such ministers retiring on or after the adoption of this Constitution, who have not otherwise been elected as a Board member in accordance with subsection a. or b. above, shall be emeritus members of the Executive Board with all the rights and privileges of membership, except the privilege of voting.

Section 3 – Financial Support. The Executive Board, from time to time, may appeal to the churches for financial support of its budget and denominational causes. The responses thereto shall be left to the individual churches.

Section 4 – Quorum. Forty members shall constitute a quorum for doing business, provided all members have been duly notified of the meetings.

Section 5 – Meetings. The Executive Board shall hold regular meetings, at such times and places as may be agreed upon.

Section 6 – Special Meetings. When action must be taken between regularly scheduled board meetings, the officers of the Executive Board may call a special meeting of the board. Notice of such meetings must be sent seven days prior to the date of the special meeting and must contain a statement describing the action to be considered.

#### **ARTICLE VIII. ASSOCIATIONAL ANNUAL**

The Association shall publish an annual report of its proceedings for distribution among the churches. The number will be determined by the Executive Board, and the cost of publication shall be provided for in the budget.

#### **ARTICLE IX. AMENDMENTS**

This Constitution may be amended at any annual session by a vote of two-thirds of the messengers present and voting. Any proposed amendment must be presented to the clerk in writing no later than the July Executive Board Meeting prior to the session in which action is to be taken.

#### **BYLAWS**

1. **ENROLLMENT OF MESSENGERS.** Provision shall be made for the enrollment of messengers duly elected by member churches. These messengers enrolled during the session shall constitute the Association. Problems arising on the floor regarding seating of messengers may be referred to the Credentials Committee (composed of the officers of the Association) for resolution. The Committee shall report its finding back to the Association.
2. **PARLIAMENTARY AUTHORITY.** The Parliamentary authority of the Association shall be Robert's Rules of Order, most recent edition.
3. **ORGANIZATION.** The Association shall organize itself to carry on the mission and business of the Association as outlined below. The information pertaining to the specific duties and procedures of the Committees, Mission Performance Units, and other bodies shall be given in the Policies Manual, which shall be prepared by the Associational Mission Strategist for approval by the Executive Board.
  - a. **Governing Bodies**
    1. The Association shall carry on its work during annual session.
    2. Executive Board shall carry on the work of the Association between sessions.  
(See Constitution Article VII, Executive Board.)
    3. **Administrative Services** – The administrative services of the Association shall consist of Administrative Committees, Special Administrative Committees, and officers elected by the Association. The purpose of the Administrative Services is to assist the Director of Missions, other Associational staff, the Associational Council, and the various Mission Performance Program Units to be faithful in carrying out their assigned responsibilities more efficiently and effectively.
    4. **Standing Administrative Committees.** Each Standing Administrative Committee is composed of six (6)



members with terms of three years each on a rotating basis. Two new members shall be elected each year.

The Standing Administrative Committees are:

Personnel Committee, Finance Committee, Nominating Committee, Trustee Committee, Audit Committee, Annual Session (Program) Committee, Resolutions Committee, and Camp Development Committee. (See the Policy and Procedure Manual for specific duties.)

5. Special Administrative Committees. Special Administrative Committees may be appointed by the Moderator as needed. The chairpersons of special administrative committees shall not serve as members of the Executive Board by virtue of their office.

Any of the above listed committees may be deleted by vote of the Executive Board.

4. Administrative Officers. The Administrative Officers of the Association shall be Moderator, First and Second Assistant Moderator, Clerk and Assistant Clerk. The Moderator shall be eligible to serve as an ex-officio member of all administrative committees.
  - a. The Associational Council. The Associational Council is composed of all directors of Associational Mission Performance Program Units, the Moderator, the chairperson of the Long-Range Planning Committee and the chairperson of the Associational Finance Committee (when budget requests are being considered in a planning phase). The purpose and functions of the Associational Council shall be given in the Policy and Procedure Manual. The Associational Mission Strategist shall serve as chairman of the Associational Council.
  - b. The Mission Performance Program Units. The primary purpose of the Mission Performance Program Units is to do the work of the Association, to directly contribute to accomplishing the Association's mission and purpose. The Associational Mission Strategist shall provide current job descriptions to each mission performance program unit. At the March Executive Board meeting, the Associational Nominating Committee shall nominate a director and a sufficient number of people to serve each unit.

The units are: Baptist Center, Seminary Extension, Camp Ministry, Discipleship Training, Evangelism, Missions Development, Music Ministry, Sunday school, Travis Estate Fund, WMU and Youth Ministry.

Each Mission Performance Program unit is composed of six members elected annually. The duties of each Mission Performance Program Unit shall be listed in the Policy and Procedure Manual.
  - c. Fellowship Council. The Fellowship Council shall consist of the Moderator and Assistant Moderators of the Association, and the presidents of groups whose primary purpose is fellowship and mutual care. The Moderator shall serve as chairman of the fellowship council. Meetings shall be called as needed.
5. STAFF. The Executive Board shall hire an Associational Mission Strategist and any other staff and office employees deemed necessary and feasible for carrying out the work of the Association. All staff and employees of the Association shall work under the oversight of the Association Personnel Committee and in accordance with the conditions set forth in any Association Personnel Policies initiated by the Personnel Committee and approved by the Executive Board. Daily supervision of all employees shall be the responsibility of the Associational Mission Strategist. The Associational Mission Strategist shall serve ex-officio on all committees of the Association.
6. PART-TIME EXECUTIVE BOARD EMPLOYEES. Persons who are both members of and part-time employees of the Executive Board may have voting privileges on the Executive Board if otherwise duly selected under Article VII, Section 2 of the Constitution except on those issues relating to their personal compensation, benefits, or areas of Associational employment.
7. AMENDMENTS. The By-Laws may be amended at any annual meeting by a vote of two-thirds of the messengers present and voting.

### **Associational Mission Strategist**

"The year of COVID-19" could serve well as the title of half of our associational year. Beginning in mid-March we witnessed the nation shutting down due to the coronavirus pandemic. The pandemic affected our DMBA churches, but not infect them with panic. Seeing how the churches, pastors, staff, committees and volunteers of the DMBA have responded reminds me of a scripture verse, "For God, who commanded the light to shine out of darkness, hath shined in our hearts, to give the light of the knowledge of the glory of God in the face of Jesus Christ. But we have this treasure in earthen vessels, that the excellency of the power may be of God, and not of us. We are troubled on every side, yet not distressed; we are perplexed, but not in despair; persecuted, but not forsaken; cast down, but not destroyed" (II Corinthians 4:6-9). I have seen churches, pastors, and lay people shine the light of Jesus into the darkness of a panic-stricken, pandemic-laden society with love and grace. I want to share just a few observations I have noticed during my first year as your AMS, specifically how I have seen your strength, love, and mercy since mid-March. I have chosen the number nineteen to coincide with the year of COVID-19 theme.

- 1. I have discerned the determination of church members to not let anything interfere with their worship and service of God. Yes, things have changed, but we have an association full of people who will find a way to worship God and a way to serve Him faithfully.*
- 2. I have noticed the adaptability of our pastors. They have had to find new ways of conducting worship, taking care of the flock, engaging in evangelism, promoting Bible study, and mobilizing for ministry. Each pastor has had to pray, plan, implement, evaluate, pray, and tweak what did not work. And they have done so marvelously! - 3. I have seen the spirit of grace prevail in many churches with those who disagree on what we need to do at this time to worship in person. Those who think we need to do more have extended grace to those who think things have gone overboard. Those who believe things have gotten to an extreme have showed mercy to those who feel like people do not take the pandemic seriously enough. I have seen a spirit of agreeing to disagree with grace.*



4. I have witnessed the work of the associational committees carrying on the task at hand but in unique ways. Some of the committees I have sat on have conducted business by Zoom, by a group phone call, and by personal attendance practicing social distancing. Bravo to a job well done making sure the work of the association continues!

5. I have beheld the benefit of Zoom. I have attended Zoom worship, Bible studies, and lots of meetings. Without Zoom many people would feel isolated and alone. With Zoom we as an association have found a way to stay connected while remaining socially distant.

6. I have detected a great diversity in ways of worshipping during the pandemic. One of the joys and privileges of my position as your AMS allows me to worship in a different church each Sunday. Some churches check temperatures before you walk in, require masks and practice social distancing with everything; including no hymnals or Bibles in the pews, no hugs or handshakes during worship time, and people placing offerings in boxes instead of plates passed around. Other churches have a much more relaxed approach allowing each individual worshipper to decide for themselves how to comfortably worship. And many churches fall in between those two scenarios. The beautiful thing? They all work. Kudos to a great job!

7. I have espied the elasticity of our associational staff and volunteers. Leslie did a tremendous job completing our beautiful website while working from home and has shown a great spirit while we keep her behind a gate. Cortney has adapted to a completely different looking Camp Schafer this year with only one group staying overnight. Gail and her volunteers have implemented effective social distancing practices to make the Baptist Center safe and productive. Dr. Thacker and his team have gotten things back up and running after a significant shut-down at the Dental Clinic; not only due to the pandemic but also two floods. I want to complement each of you for your accomplishments.

8. I have caught sight of a can-do attitude of everyone involved with associational work. The work has changed but not stopped. The pandemic has altered the way we do things, but not derailed the mission. I praise each person involved with the association for your faultless and tireless efforts to accomplish the work of the Lord.

9. I have glimpsed the growing use of Facebook worship. Some of our churches already had an on-line presence before COVID-19. They have just expanded it since mid-March. Now many of churches have utilized this wonderful opportunity to preach the Word and worship the Savior. I have received reports that the number of viewers in our churches' Facebook worship far exceeds the number of people they had attending in-person worship before the virus.

10. I have identified imaginative ways of doing ministry among our churches. When you have a heart for serving and ministering to those in need you will find a way, and our churches have. They have visited people either from their cars or in their front yards. They have made masks to hand out for free. They have conducted virtual Vacation Bible Schools. They have found ways to connect with people watching their worship on-line who have needs and have met those needs. I commend each of you in your flawless execution of imaginative ministry.

11. I have discovered discouragement turning into encouragement. When the pandemic first hit many pastors and church leaders felt discouraged about not knowing what to do next. But it did not take long for them to discover God in the process, and a sense of how to reimagine ministry. That brought much encouragement as people continued to get saved, ministries continued to serve, and the gospel proclaimed to more people than ever before. I applaud your meticulous efforts in searching for the hand of God.

12. I have noted the importance of praying with pastors and staff. I have enjoyed so much getting to know pastors, staff, and lay leaders as I have visited each church in our association for prayer. I have loved seeing your hearts for serving the Lord and hearing how God has come through for you time and time again. Many have told me how much better they feel after prayer, and I consider it a privilege to stand in the gap for you.

13. I have spotted struggles turning into strengths. I salute your perfect dependence on the Lord to make it happen.

14. I have watched pastors navigate the tension between two different camps. Many pastors have told me that they have noticed two different camps arising during the pandemic. Some in their congregation think the media has made too much of this virus and believe things should quickly return to normal. Others in their congregation believe that people do not take the virus seriously enough and even more restrictions should be imposed. Pastors, I have to give you accolades for your masterful way of listening to and effectively ministering to both camps without excluding either one.

15. *I have distinguished a desire to honor God. No matter how you have felt about the pandemic and the social distancing mandates, you each have a desire to do what will best honor God with your words and actions. I admire your skillful way of letting God's Will rise above your wants and needs.*

16. *I have made out the malleability of staff in churches. You have had to change many things to stay relevant and effective in these changing times; from the way you lead worship, to conducting Sunday school and VBS, to facilitating small groups, to leading ministries and discipleship. I give you adulation for your artful handing of all the logistics to make your ministry happen.*

17. *I have observed the pleasant surprise of sustained or increased giving to the churches through on-line formats. Time and time again I have heard of giving to your churches either staying the same or even increasing during the pandemic. I pay homage to your artistic ways of helping faithful people give generously to their church.*

18. *I have perceived the power of prayer-walking when I could do nothing else. For half of March, all of April and May I have stayed away from personal contact with you. But I never stopped praying for you. I considered it a joy and privilege to drive to your church, walk around it, and pray for you. I prayed for each person that would eventually come through your doors that they would feel the love of Jesus through your words and actions. I prayed that each person who left your doors would have a personal relationship with Jesus Christ. And I prayed that God would sustain and encourage you until you worshipped together again in person.*

19. *I have viewed vibrant worship services as people celebrated God while not taking for granted the joy of gathering together. Once you began having worship services again, I eagerly began attending them. I loved the parking lot worship experiences with some people using the horn to signal Amen! And I have thoroughly enjoyed seeing the smiles in the eyes above the masks of the people who have gathered together in person to worship. The Daviess-McLean Baptist Association consists of an amazing group of people, and I feel honored to serve as your Associational Mission Strategist.*

### **Christian Dental Mission**

The Dental Mission is completing its 24th year as a DMBA ministry dedicated to providing emergency and basic dental care for people in our Daviess and McLean County region that are experiencing financial hardship, while seeking to show them the love of Christ through dentistry and to share the Gospel. Many come to us with various types of needs, whether it be physical, emotional, or spiritual, and it becomes an opportunity for us to minister to them in their need. Patients come to us who are screened at the Help Office of Owensboro for financial need and receive a voucher. Qualifying patients must show not only financial need, but be without any form of dental insurance.

This year has seen its challenges as we have had to confront the COVID-19 Pandemic and two floods that have entered the front rooms of the clinic from the street overflow. The Mission was closed in the months of April and May due to the pandemic, but returned to operation in the month of June with added infection control protocols. Two summertime heavy rains caused flooding and in one case, canceled a clinic for flood mitigation. The Baptist Center director, Gail Boling, is to be commended for leading the emergency mitigation at the times of the flooding. Thankfully, we had no real damage to the facility, and our computers and dental equipment were totally unharmed. It certainly caused an interruption in our ability to minister to those in need, but we are making a great come back.

During this period, we have had two volunteer dentists, two dental hygienists, and 13 volunteer support

staff members serving at the dental clinic. We have added one hygienist, but lost one, and added one chaplain (a DMBA pastor, Eddie Duke) this year which has provided for a great need. We care for our patients on two different Friday mornings a month with two teams consisting of a dentist, dental assistant, dental technician, receptionist, dental hygienist, and chaplain. In addition, we have had two volunteers that serve on a facility maintenance team. We are seeking 1-2 more dentists and dental hygienists that are called to missions that could help us form more teams to be available to serve those in need more often. Hopefully, recruitment of volunteers will be a focus in the coming year as we team with our new Associational Mission Strategist to seek mission-minded people to serve.

We are happy to report that through the large gift of the DMBA several years ago, the clinic continues to enjoy an x-ray unit that enables digital radiography and a digital radiography system that makes diagnosis more efficient and preserves diagnostic records to modern standards. This year, the DMBA made significant gifts to the clinic to include: a new autoclave sterilizer that will provide a greater capacity for dental instrument sterilization in the future; a new dehumidifier to assure that we have better flood mitigation and moisture control in the facility; and a new amalgam separator with plumbing installation that is required by new codes to capture amalgam from dental procedures in our sewer lines. Also, through the generous support of the DMBA, we continue to have basic utilities, pest control, dental supplies and maintenance, and telephone and internet provided. In addition, a local retiring dentist, Dr. Mike Johnson, donated an assistant stool and five dental highspeed handpieces to the Mission.

This year has seen a good number of people reached for greater oral and general health through treatment for dental decay with fillings, and hopeless teeth and dental abscesses treated with extractions or surgical removal. Periodontal care has been provided through dental cleanings. In addition, many have benefited from prevention counseling to include oral hygiene instruction, dietary counseling, and smoking cessation. Many have experienced times of intentional sharing of the Gospel and prayer by our chaplain and other volunteers, and while none chose to accept Christ, one recommitted to follow Lord. We have planted seeds with many others for a future harvest, and have certainly ministered to many believers as well.

Once again, thank you for your prayers and continued support of this front-line mission in our community to bring the Good News of Jesus Christ to many people through dentistry.

Pray that lives are changed through our efforts. Instead of toys this year we will be sending handwritten personalized Christmas cards to every child whose name is turned in. A Bible will be sent to them, as well. Inside the sealed Christmas card, we will put a gift card for the child to be able to purchase something they would like to have.
